IMPORTANT NOMINATION MEETING INFORMATION

In accordance with Part 8 and Part 9 of the *Dzawada'enuxw First Nation Election Code 2011* there are a number of provisions that **MUST** be satisfied in order for a nomination and candidate qualifications to be approved by the Chief Electoral Officer. Be sure to consult these Sections of the DFN Election Code 2011 and/or contact the Chief Electoral Officer for more information.

You may nominate in person at the Nomination Meeting or through a Mail-in Nomination procedure. Please be advised that a Mail-in Nomination package has been sent to all Electors who ordinarily reside off-reserve and for whom a proper mailing address has been provided.

Any Elector 19 years or older on 12th June, 2015 and listed on the Registered Voters List may nominate and second and/or be nominated for candidacy.

Any Elector may nominate or second **no more** than one eligible person for the office of Chair; and the number of eligible persons (4) for the office of Councillor.

Please note that in order for a nomination to stand it must be seconded by an eligible Elector at the Nomination Meeting or receive an eligible second Mail-in Nomination for the same office.

Electors who want to receive information from candidates may inform the Chief Electoral Officer at any time in writing of their approval to release their mailing address and contact information to Candidates for this purpose.

Any voter may vote by mail-in ballot, rather than in person at a polling station.
